CPA PEP modules tailored to Indigenous learners

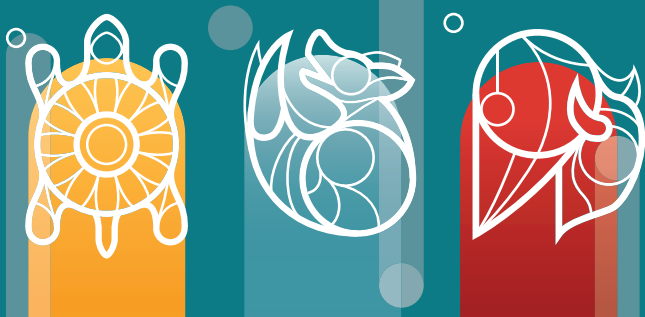
About

The Aboriginal Financial Officers Association of Alberta, the CPA Western School of Business, and CPA Canada, in collaboration with Indigenous subject matter experts, have developed CPA PEP modules specifically designed for Indigenous learners. These modules, led by Indigenous instructors and supported by Indigenous facilitators, seamlessly integrate Indigenous culture and context into the curriculum. Supported by the Western Provincial CPA bodies — CPA British Columbia, CPA Alberta,

CPA Saskatchewan, and CPA Manitoba — the modules offer a blend of community-based real-time, individual, in-person, and remote learning, providing a flexible and comprehensive approach to education.

Community-based real-time learning

The community-based real-time learning activities will enable facilitated discussions, create a sense of community within the cohort, and provide opportunities for peer learning and support.

Introductory webinar

Starting off the Core 1 module, this webinar provides a comprehensive introduction to the CPA profession and details specific to the module.

In-person Opening and Closing sessions

Held at the beginning and end of each module to foster a sense of community. These sessions encourage collaborative learning initially and later focus on exam preparation.

Virtual and In-person Satellite sessions

Regular sessions in each module where learners work together on technical materials, integrating Indigenous culture and context through activities and guest speakers.

Candidate-led webinars

Offered throughout each module, these cover various topics including case planning and exam strategies, all directed by the candidates.

Individual learning

The individual learning activities are designed to offer flexibility, allowing learners to independently progress through parts of each module at their own pace, preparing for each learning session and the final exam.

Individual learning activities will include a self-paced e-book, quizzes, integrated problems marked by a facilitator with feedback, a practice case marked by a facilitator with feedback, and the opportunity to write practice final exams.

Final examination

Each module culminates in an examination that must be passed to successfully complete the module.

There are approximately 33 locations in western Canada where the exam can be written. If you live in a remote location, other arrangements can be made for invigilation.

Entry Requirements

To be admitted to CPA PEP and participate in the modules for Indigenous learners, applicants must have and provide proof of:

- An undergraduate degree or higher (in any discipline) or be eligible for Mature Status entry
- 120 credit hours of post-secondary education or be eligible for Mature Status entry
- Successful completion of all 14 required prerequisite courses
- Indigenous Status

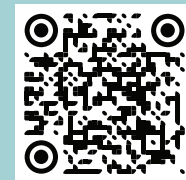
